These are (1) Noi Bai (Ha Noi), (2) Cat Bi (Hai Phong), (3) Vinh (Nghe An), (4) Phu Bai (Hue), (5) Da Nang, (6) Cam Ranh (Khanh Hoa), (7) Phu Quoc (Kien Giang), (8) Tan Son Nhat (Ho Chi Minh), (9) Can Tho. ACV is 95.4% owned by the Vietnamese Government and having its registered address at 58 Truong Son, Ward 2, Tan Binh District, HCMC, Socialist Republic of Vietnam.

CENTRAL JAPAN INTERNATIONAL AIRPORT CO., LTD. (hereinafter referred to as "CJIAC") is a company limited that operates an international airport in Tokoname City, which is adjacent to Nagoya City. CJIAC is 40% owned by the Japanese Government, 10% owned by the local governments and 50% owned by private entities mainly in central Japan area and having its registered address at 1-1 Centrair, Tokoname City, Aichi Prefecture, Japan.
